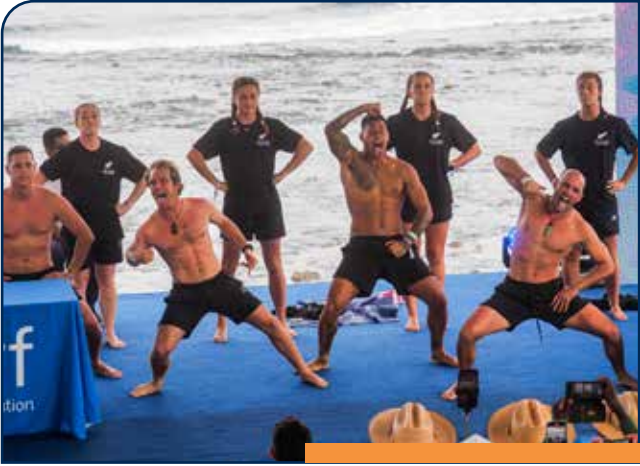

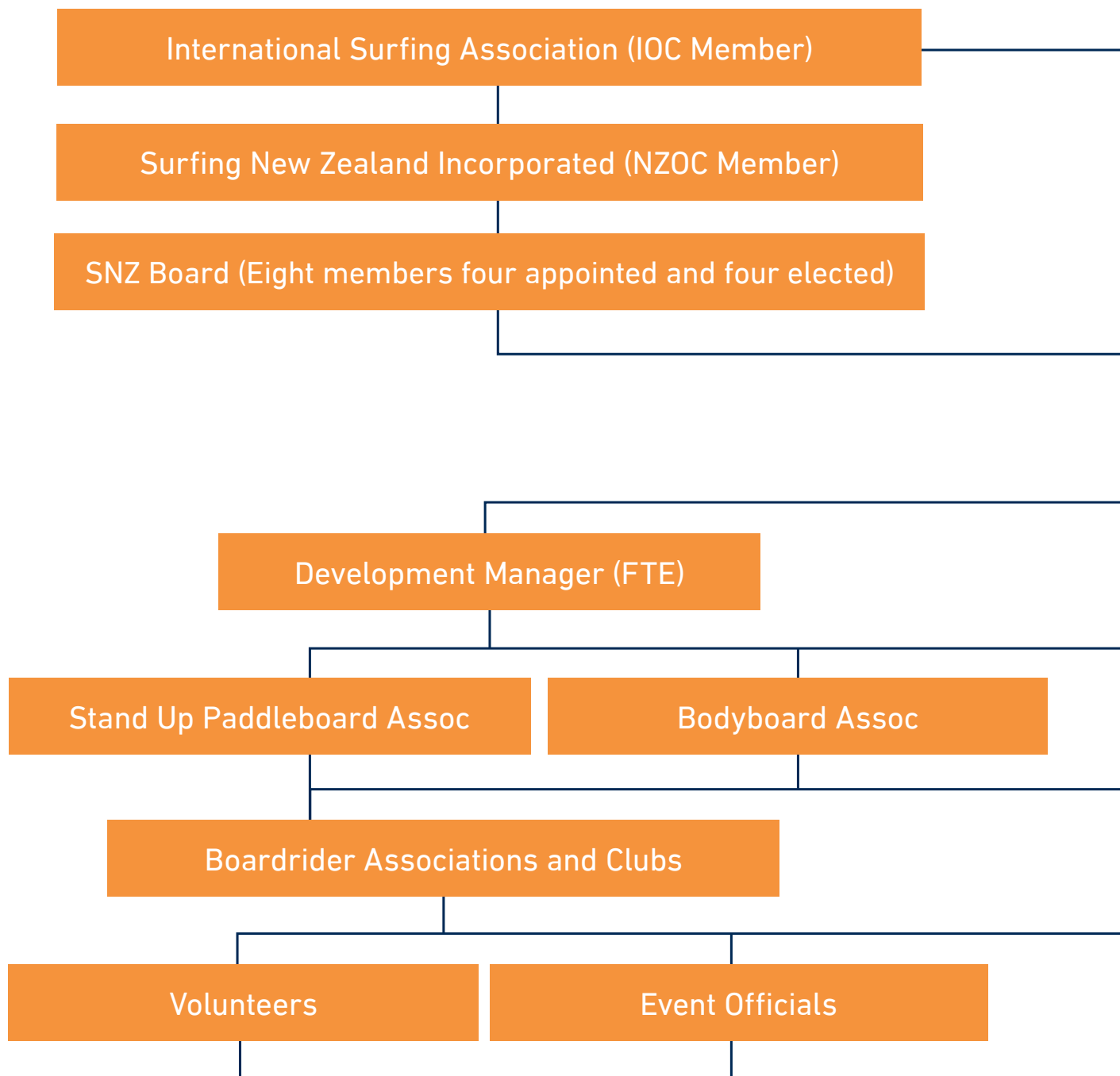




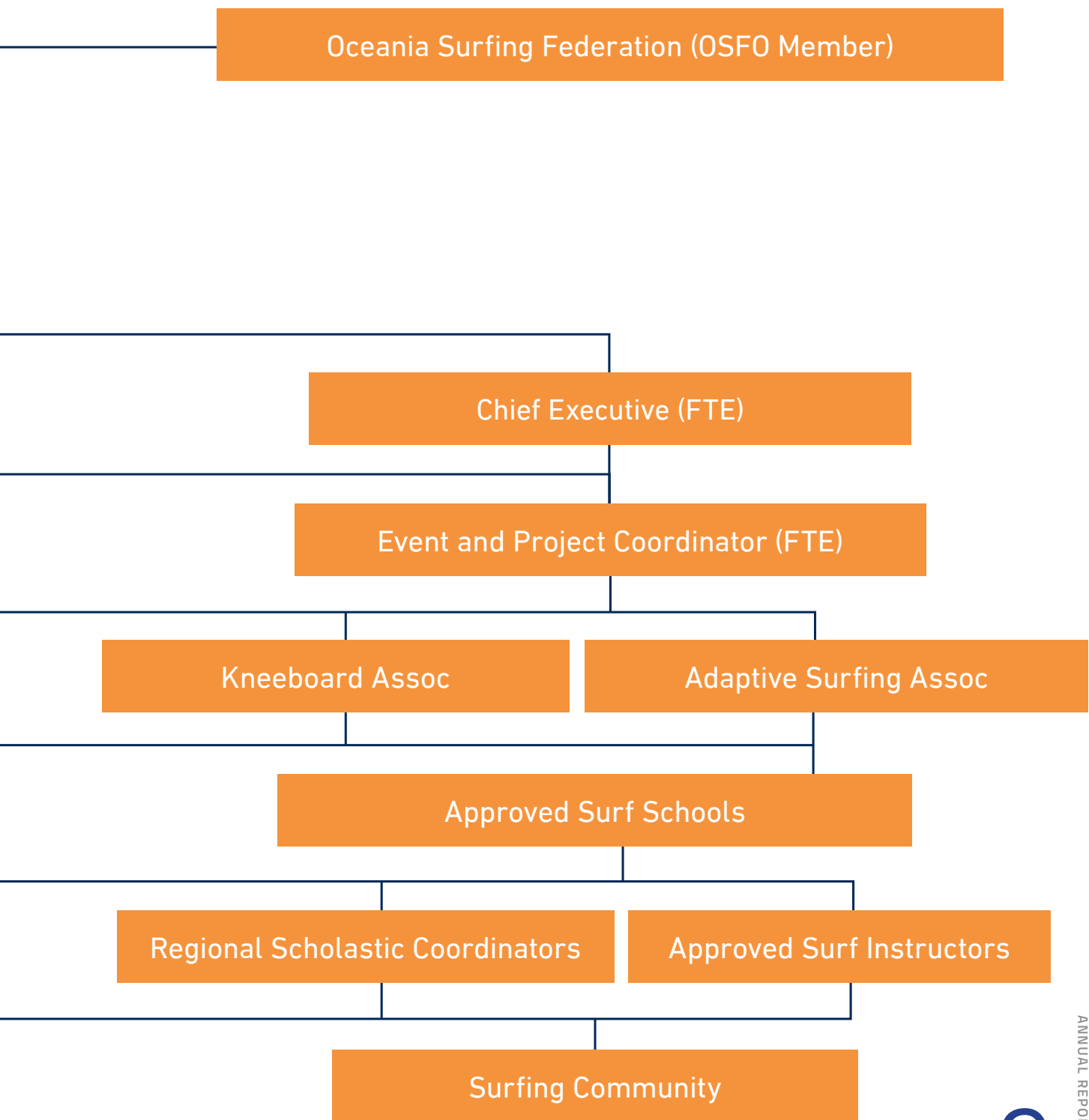

# CHAIR AND CEO REPORT

ANNUAL REPORT 2023



On behalf of the board, we are pleased to present our annual report for the financial year ended 30 June 2023. Looking back, 2023 was a big year for Surfing New Zealand (SNZ) in and out of the water. Importantly, with the removal of Covid restrictions the team could deliver on its vision, purpose and daily mission – to enrich lives by creating experiences that share the aroha of surfing.

## FINANCIAL RESULT

For the financial year ending 30 June 2023 (FY2023), SNZ generated a net surplus of \$14,200 on revenue of \$670,000. Revenue was up 20% and expenditure was down 5%. This was a material improvement on the net loss from FY2022 and helped to rebuild SNZ's cash position and balance sheet after a couple of challenging Covid impacted years.

## GOVERNANCE

The board continued to focus on developing the organisation's governance, leadership and operational frameworks. A number of new policies and tools have been implemented to improve governance and reporting. An important contributing factor is the balance of experienced and new directors each with diverse skills, experience and capabilities. In June, the South Island Elected Member of the board, Russell Ritchie, resigned. Russell was a director of SNZ for ten years and a tireless member of both the Surfing New Zealand and South Island Surfing Association volunteer networks, supporting everything from events to development camps and other initiatives. Thanks Russell for your contribution that spans well past the last ten years.

## STRATEGIC DIRECTION 2024 - 2026

During the first quarter of calendar year 2023 the board completed an organisational review of SNZ to consider, evaluate and set the strategic direction for 2024-2026. The Strategic Direction, which was presented to clubs in August, sets out our vision, purpose, values and key areas of focus for 2024 - 2026. The focus is now executing the strategic initiatives which underpin the strategic plan. The Strategic Direction is available on SNZ's website.

## PARTICIPATION AND COMMUNITY

SNZ is the sum of all the surfers, coaches, officials, judges, administrator and volunteers in clubs, schools, associations and affiliates across Aotearoa. When you tally figures across our network of affiliated clubs, you get to see the enormity of our community. 141 club surfing events, 238 learn to surf sessions at club level, well in excess of 700 volunteers. It is great to play a role in the delivery of these services to the surfing community, whether that is through leadership at a national level or directly delivering Surfers Rescue 24/7 and the popular Wave Warriors Learn to Surf days or upskilling our vast network of surf instructors that are vital for the start of many surfing journeys.

## EVENTS

Our domestic event calendar was filled with 19 national events which reached from Auckland to Dunedin. 2,125 entries were recorded across the season from the Primary School Champs through to the National Championships, the Grom Series, Longboard Series and

NZ Surf Series. Our biggest event was the National Championships with 439 entrants, an overflowing entry level that has forced a change to the way the National Championships are being held in 2024. Further change is coming to the NZ Grom Series as we target a broader geographical reach of events and higher participation in the regions than what we can cater for at current events.

## HIGH PERFORMANCE

Watching Saffi Vette and Billy Stairmand capture the Oceania continental qualifying positions for Paris 2024 (Tahiti) was certainly a highlight of the year. As we move into our second Olympic Games, it is becoming evident that the World Surfing Games event prior to an Olympic year is the second pinnacle event of the Olympic cycle. We look toward Paris 2024 with interest and the chance of qualifying further athletes at the 2024 World Surfing Games in February next year. While the Olympics continues to be a focal point, the World Surf League produced amazing highlights too with three WQS victories from five podium finishes, Saffi breaking through for a maiden victory alongside Billy Stairmand and Paige Hareb.

## PARTNERSHIPS & FUNDING

SNZ achieves nothing without the support of an extensive group of stakeholders. Our central government support through Sport New Zealand and High Performance Sport New Zealand extends beyond the financial investment we receive and we are grateful for the relationships we

continue to build. The New Zealand Olympic Committee play a major role in supporting our athletes for Olympic success. Community Trusts are the financial backbone of most sport in New Zealand and they make a considerable contribution to SNZ. A big thanks goes to New Zealand Community Trust, Lion Foundation, Pub Charity and Aotearoa Gaming Trust for their direct support and the support of boardrider clubs around the country. Volkswagen and Better Beer backed our events in 2023 alongside staunch support from the surf industry who make our event programme possible.

## PEOPLE

SNZ is a small organization with a staff of three; however there are hundreds of contractors and volunteers. A special thanks goes to our board that has brought fresh and diverse thinking, and used their experience and capabilities to help the sport and SNZ move forward. Our dedicated staff who put in big hours over the summer season to get our nationwide events and initiatives completed. The sixty plus event staff that give up their weekends to support events when they could be surfing themselves. And the volunteers who stretch well into the hundreds at boardrider club level, delivering community projects and creating experiences to share their aroha of surfing.

# PARTICIPATION AND COMMUNITY

## A THRIVING SURFING COMMUNITY

Work within the participation and community focus area stretches across the country through initiatives led by Surfing New Zealand and the network of boardrider clubs and surf schools.

Valuable feedback was provided from the network of 35 boardrider clubs this year via the annual survey. Clubs vary significantly in size from 30 members up to as many as 500 with the majority of clubs sitting below 100 members with 35% being female. Membership fees continue to be the biggest form of revenue for clubs with individual membership ranging from \$15 - \$75. Boardrider clubs held a total of 141 community surfing events and 238 learn to surf sessions in 2023.

Our ISA education programmes continue to prove popular year-on-year with ISA Level 1 Surf Instructor Course participants reaching a record 96 in 2023. The online judging webinars have offered stakeholders a different way to upskill and take valuable lessons back to clubs with 58 participants across four courses including female only webinars and one focussing on longboarding.

Surf schools remain the entry point for many first timers and especially those new, and with no connection to the sport. Our network of 28 accredited surf schools offer up the best possible experience for these newcomers.

### 2023 NZ Grom Series

New Zealand's junior surfers had eight stand-alone events focussed on the Under 18, 16 and 14 age divisions as well as three additional events mixed in with all age groups. Most junior events sold out within days due to a capped entry level at each event. 338 surfers participated in the series, an 11% decrease in participation with two less events compared with 2022. With events at capacity, we have worked through the off season to restructure the NZ Grom Series and we look forward to bringing the new structure to life in 2024.

## INTERNATIONAL RESULTS

New Zealand athletes performed at the pinnacle event of the year securing two Olympic qualifications for Paris 2024 (Tahiti). Billy Stairmand and Saffi Vette claimed the continental qualifying positions at the ISA World Surfing Games held in El Salvador. The two athletes went on to be part of the ISA Development Camps held in Tahiti as athletes prepare for the Olympics. This opportunity was supported by the IOC Olympic Solidarity Fund.

New Zealand secured 3/13 positions on the WSL Challenger Series for the Australia / Oceania Region.

Jack Tyro became the first athlete to qualify for a WSL World Longboard Tour event by winning the trials at Bells Beach. Tyro went on to finish 17th in the event.

We continued to build our relationship with both High Performance Sport New Zealand and the New Zealand Olympic Committee. Both relationships have proved invaluable as we build toward a more structured approach to high performance surfing. We secured further Olympic Solidarity funding to support the road to Paris and six coaches were included in the Core Knowledge programme. Pathway development funding from HPSNZ helped us deliver two training camps for our Junior Surfing Team who compete in Brazil at the end of November.

Our relationship with Sport New Zealand has been vital over the past twelve months as we build a platform for growth.

Our clear strategic plan has led to additional capability support from Sport New Zealand in the community sport space. This is via systems and policy support and integrity funding. In the later part of 2023, we have been offered support in the commercial and funding space which has potential to grow.

High Performance Sport New Zealand has helped fund our Olympic qualification campaign and pathway development for our Junior Surfing Team. Financial support has been complemented with development opportunities for our top coaches.

The New Zealand Olympic Committee values the addition of surfing to the Olympic family and our athletes have been, and will continue to be, used in promotions in the build up to Paris 2024. The support the NZOC provides through Olympic Solidarity Funding has been important for our athletes. Opportunities for SNZ staff to present at the Paris 2024 Forum will give our sport an increased profile as well as the ability to network with all other sports administrators.

Community Trusts are crucial to sport in New Zealand and surfing is no different. This funding stream supports staff wages, event delivery and event equipment for Surfing New Zealand and our network of boardrider clubs.

The surf industry remains at the heart of our event delivery, providing participation opportunities the length of the country. Whether this is for the 19-year-old Billabong Grom Series, the iconic Rip Curl Pro Raglan or the growing Hurley Boardrider Club Championships through to the support of the surf retailers such as Backdoor and Exit Surf on a national and regional level.

Volkswagen drove us around the country delivering initiatives in 2023 and Better Beer came on board to make things fun and enjoyable at the National Championships and the Hurley Boardrider Club Champs.

We would like to acknowledge all of our partners for the investment they make in the New Zealand Surfing Community.

# GOVERNANCE AND OPERATIONS

## COMMERCIALLY SUSTAINABLE, SOCIALLY AND ENVIRONMENTALLY RESPONSIBLE.

The board and management were delighted to bring the 2024 – 2026 strategic plan to life this year. It was a major piece of work spanning over six months that sets the direction for the next three years. Data from several surveys provided insights for the plan:

This foundation document has already proved valuable opening up additional support and opportunities from our partners and it will continue to do so. Where can you expect to see the plan in action?

- > Used by the SNZ Board to maintain clear direction and focus.
- > Shared with all stakeholders.
- > Used by management to complete operational plans and initiatives.
- > Integrated into all policy and organizational documents.
- > Communicated across all initiatives.
- > Review, assess and revising actions against plan as a working document.

The board has worked on several additional governance documents including the updated board charter, health and safety, HR and financial systems and controls. These documents and policies further strengthen the organisation for long term stability.

We have now spent one year using the Live Heats platform for membership and event management. The platform has streamlined our events and continues to add value for membership. We now have seven boardrider clubs under our federation model which helps us build a clearer picture of our membership for Sport New Zealand reporting. We will continue to highlight the benefits of using this system to our network of boardrider clubs, the ease of use and time saved with registrations.

# Notes to the Financial Statements

## Surfing New Zealand Inc For the year ended 30 June 2023

### 1. Statement of Accounting Policies

#### Registration and Reporting Standards

The entity reporting is Surfing New Zealand (Inc) and its subsidiary (The Ultimate Waterman Limited). Surfing New Zealand is an incorporated society under the Incorporated Societies Act 1908. Surfing New Zealand (Inc) is not a reporting entity under the Financial Reporting Act 2013. The financial statements are Special Purpose Financial Statements prepared for internal management purposes using principals contained in the Income Tax Act 2007.

The accounting principles recognised as appropriate for the measurement and reporting of the Combined Statement of Financial Performance and Statement of Financial Position on a historical cost basis are followed by the club, unless otherwise stated in the Specific Accounting Policies.

The information is presented in New Zealand dollars. All values are rounded to the nearest \$.

The Ultimate Waterman Limited was formed in November 2010. Surfing New Zealand (Inc) is the sole shareholder. These financial statements represent the consolidation of both entities. The consolidated financial statements are prepared by combining the financial statements of all entities that comprise the consolidated entity, being the incorporated society, Surfing New Zealand (Inc), and its controlled entity.

#### Principal Activities of the Society

To administer and promote surfing within New Zealand.

#### Specific Accounting Policies

The following specific accounting policies which materially affect the measurement of the Statement of Profit or Loss and Balance Sheet have been applied:

#### Property, Plant and Equipment and Investment Property

Property, plant and equipment are recorded at cost less accumulated depreciation.

#### Depreciation

Depreciation is provided on all tangible assets at a rate which will write off the cost of the assets over their estimated useful lives.

## Goods and Services Tax (GST)

Revenues and expenses have been recognised in the financial statements exclusive of GST except that irrecoverable GST input tax has been recognised in association with the expense to which it relates. All items in the Balance Sheet are stated exclusive of GST except for receivables and payables which are stated inclusive of GST.

## Trade Receivables

Trade receivables are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method, less an allowance for any uncollectable amounts. Individual debts that are known to be uncollectable are written off in the period that they are identified.

## Income Tax

Surfing New Zealand (Inc) is subject to income tax pursuant to the Income Tax Act 2007. The Ultimate Waterman Limited is subject to income tax but no income tax has been provided for in the year ended 30 June 2023.

## Changes in Accounting Policies

There have been no changes in accounting policies. Policies have been applied on a consistent basis with those of the previous reporting period.

A board member has contracted to act as a judge. Clause 18.10 prohibits the employment of board members.
